#### Problem Properties

There is a piece of property located in a small subdivision that needs attention or has been abandoned. This has been an ongoing issue for about 6 months and has been brought to the attention of the Sheriff's Dept and the Health Dept. It was stated it is hard to enforce anything without an ordinance. There was a suggestion and discussion to adopt a nuisance ordinance. There may be a need to adopt an ordinance to protect citizen's property values however it should not be too overly restrictive. This ordinance would be for properties that are considered dangerous and inhabitable and pose a health and safety concern. There was board concern and the need to be cautious with the restrictions the ordinance would impose. It was stated some subdivision ordinances may state restrictions. It was suggested to look at

other counties in regards to a nuisance ordinance or amending the Health Department ordinance. Member J. Douthit will seek advice from Aaron Jones, State Attorney, about enhancing the Health Department ordinance for nuisance concerns.
