Sheriff's Office/Sheriff Kuhns

- Sheriff Kuhns reported since Jan of 2024 average daily inmate population has doubled increasing meals served with current population at 32.1. Sheriff Kuhns stated he is unsure what increase is attributed to. Sheriff Kuhns stated in all agencies within county, the County sworn officers are making more arrests with jail time.
- T. Buhnerkempe stated arrest warrants served are up 55% in the 1st quarter this year compared to the 1st quarter last year.

K. Rhodes reported Coroner's office getting prepared for move to new building.

911/Tina Daniels

• T. Daniels reported 3 projects in the works; replacing CAD GIS server, working on 911 hardware refresh, new furniture along with new phone refresh. T. Daniels also shared updates in lighting and tile.

Animal Control/Michelle Shoot

M. Shoot shared plans to collaborate with EARS on adoptions, fostering, spaying/neutering. M. Shoot stated they are getting
more volunteers through added community events along with participation in some commercial advertising and reels aiding
in community involvement.

Emergency Preparedness/Health Department

- A. Wille reported multiple states with surges in measles cases with 800 cases throughout the U.S. in 25 states with no reported cases in Illinois. A. Wille stated contract tracing will be in play if measles reported in county. A. Wille shared attendance to meeting on contractible diseases with hospital later this month.
- A. Wille stated West Nile Virus measures will be in effect along with tick surveying this spring/summer.
- A. Wille stated residential sharps container is still in use at Health Department with free containers available to the public.
- D. Campbell inquired on ingredient listing for farmer's market type environments. A. Wille confirmed cottage food operators need to list ingredients along with sub-ingredients and allergen labeling at all times.

Dive Rescue Team/Terry Trueblood

- T. Trueblood absent.
- D. Campbell stated J. Kyle reported being called out during flood, but recalled before arrival to scene.
- D. Campbell stated J. Kyle also reported having plenty of divers, however in need of more shore responders.

K-9 Search and Rescue/Kevin Bullard

- D. Campbell stated K. Bullard reported will be hosting Canine Seminar on Sept 17-20th with 50 signed up from all over US along with 12 canines getting re-certified on April 12-14th.
- D. Campbell stated K. Bullard also reported two (2) call outs from Fire Marshall's office.

- G. Koester reported signs were placed during storms for flooding.
