### ARPA Reports Review

The board members reviewed the monthly spreadsheet and tracking report on the ARPA funds. It was suggestion a notice to be sent to the entities about their unspent funds.

#### ARPA Funding

- TREC Trail Disbursement of Funds
   An invoice for \$1,748.14 was submitted from the Effingham County Highway dept. for trail maintenance. Greg Koester, County Engineer, talked about the work completed and upcoming projects. Member D. McCain made a motion to recommend to the full board for approval of the payment and distribution of APRA funds in the amount of \$1,748.14. Member T. Ellis seconded. Unanimous. *Motion carried.*
- County Board Member Tablets Disbursement of Funds
   The total cost for ten tablets and stands was \$2,595.11. The earmarked amount was \$3,000.00. Member J. Douthit made a motion to recommend to the full board approval

of the payment and distribution of ARPA funds in the amount of \$2,595.11. Member J. Deters seconded. Unanimous. *Motion carried*.

# One Hope United

Member D. Campbell stated the 708 Board agreed not to utilize the ARPA funds for One Hope United. They previously requested \$10,000.00 in ARPA funding. A formal denial letter will be sent to One Hope United. Member J. Deters made a motion to recommend to the full board to remove the earmark of \$10,000.00 in ARPA funds and return \$10,000.00 to the ARPA fund. Member C. Keller seconded. Unanimous. *Motion carried.* 

#### Childcare Research Committee

Courtney Yockey presented a scholarship application for the Effingham County Childcare scholarship program to the board for approval. The scholarship meets the criteria for approval. Member J. Douthit made a motion to recommend to the full board for approval of the scholarship application and the disbursement of \$3,600.00 in ARPA funds. Member C. Keller seconded. Unanimous. *Motion carried.*

### VAC Superintendent

The Veterans Commission currently has two part-time employees. Phil Toops, VAC manager, will be stepping down and has recommended the department to staff one full-time employee. This will be a 40 hour a week position with a pay of \$28.85/hr. There is funding in the budget for this full-time position. Member J. Douthit made a motion to recommend to the full board to approve the amendment to the salary ordinance to add the VAC Superintendent position and rate of pay. Member J. Deters seconded. Unanimous. *Motion carried.*
