The County Board of Effingham County, Illinois met pursuant to a regular meeting on Monday, September 16, 2024 at 4:00 p.m. in the County Board Room, County Building, City of Effingham, and State of Illinois.

7. EXTRACTED CONSENT AGENDA ITEMS

 #7-A - APPROVE \$53,100.00 AS REMAINING EARMARK IN ARPA FUNDING FOR CHILDCARE RESEARCH COMMITTEE GAP SCHOLARSHIP WITH OUTSTANDING PREVIOUSLY EARMARKED FUNDS RETURNING TO ARPA FUNDING

Member N. Soltwedel pulled this agenda item to amend the disbursement amount from \$53,100.00 to \$51,300.00. This adjustment is for a GAP scholarship applicant who is a teacher and will not have employment during the summer months. Member N. Soltwedel made a motion to amend the ARPA disbursement to \$51,300.00 of remaining earmarked ARPA funds for the GAP scholarship and with any outstanding previously earmarked funds returning to the ARPA fund. Member M. Buzzard seconded. *Motion carried* on a roll call vote 8 ayes; 0 nays; 0 absent; 0 abstain.

• #7-B - APPROVE HOPETRUST AS THE EMPLOYEE GROUP HEALTH CARRIER FOR 2024-2025

Member C. Keller pulled this agenda item to make a request for the current insurance provider Weis Insurance to discuss health insurance. Kate Passalaqua with Weis insurance spoke to the board to present additional ideas or options to possibly utilize additional funds if the board was going to increase the employer contribution. She noted the insurance plans presented will remain the same. She requested to retain the coverage for the dental and vision plans. There was board discussion at the committee meeting that the recommendation was with HopeTrust, there was due diligence at the employee meetings about their health insurance carrier preference and the amount of the employer contribution which will be discussed at the special tax and finance meeting on October 15, 2024. Member N. Soltwedel made a motion to approve HopeTrust as the employee group health insurance carrier for 2024-2025. Member T. Ellis seconded. Member C. Keller opposed. *Motion carried*.

• #7-C - APPROVE \$19,500.00 DISBURSEMENT FROM REVOLVING LOAN FUND TO HEARTLAND HEALTH FOODS

Member S. Rich pulled this agenda item to noted she is in favor of the disbursement. She wanted to give awareness and gave some highlights of the Revolving Loan Fund program. The owner of Heartland Health Foods spoke about the benefits and the process to apply for the funds. Member D. Campbell made motion to approve the disbursement of \$19,500.00 from the Revolving Loan Fund to Heartland Health Foods. Member J. Deters seconded. *Motion carried* on a roll call vote 8 ayes; 0 nays; 0 absent; 0 abstain.

• #7-D - APPROVE SCHEDULING ONE (1) PUBLIC HEARING IN THE NEXT THREE (3) MONTHS TO EDUCATE THE PUBLIC ON OPIOID FUNDING

Chairman J. Douthit pulled this agenda items to note the date of the public forum hearing for the Opioid Settlement funding. It was recommended to hold one public meeting and the proposed date will be Thursday, October 24, 2025 at 6:00 p.m. Member S. Rich made a motion

to set the public hearing date for the Opioid funding to be on Thursday, October 24, 2024 at 6:00 p.m. Member D. McCain seconded. Unanimous. *Motion carried.*

8. APPROVE DENTAL AND VISION COVERAGE FOR 2024-2025 WITHOUT COMMITTEE RECOMMENDATION

It was noted Delta Dental will be the carrier for the dental insurance and Mutual of Omaha will be carrier for the vision insurance with no increases to the premiums. Weis Insurance will be the insurance agency. Member J. Deters made a motion to retain current dental and vision insurance coverage with Weis Insurance for 2024-25. Member D. McCain seconded. Unanimous. *Motion carried.*

9. APPROVE \$148,680.00 DISBURSEMENT IN ARPA FUNDING IN PAYMENT OF FINAL INVOICE FOR FIRE DEPARTMENTS RADIO PURCHASE WITHOUT COMMITTEE RECOMMENDATION.

Member J. Deters made a motion to approve the final payment of \$148,680.00 for the fire department radio from ARPA funding. Member S. Rich seconded. *Motion carried* on a roll call vote 8 ayes; 0 nays; 0 absent; 0 abstain.

10. APPROVE CONTRIBUTION TO EFFINGHAM CHAMBER OF COMMERCE FOR TRADES, SKILLS & MANUFACTURING DAY WITHOUT COMMITTEE RECOMMENDATION

It was noted last year the annual contribution to the Effingham Chamber of Commerce for Trades, Skills and Manufacturing Day was for \$2,000.00 from Economic Development. Member T. Ellis made a motion to approve the \$2,000.00 contribution to the Effingham County Chamber of Commerce for Trades, Skills and Manufacturing Day from Economic Development. Member D. McCain seconded. *Motion carried* roll call vote 8 ayes; 0 nays; 0 absent; 0 abstain.

- Michelle Kollmann, County Clerk, reported early voting starts Thursday, September 26. 2024 and voting will take place on the first floor of the County Building in the Benwood Conference room from 8:00 am to 4:00 pm Also, any voter who requested a vote by mail ballot the first day to mail those is also September 26. Election judge training will take place on October 9th at the Effingham Public Library.
- Paul Kuhns, Sheriff, informed the board he will be on air with Cromwell Radio to discuss mental health issues in the County Jail.
- Deb Ruholl, Treasurer, noted the Treasurer's office has collected over 42 million-dollars in real estate taxes. The first distribution will be on October 6, 2024 and the second installment is due on October 18, 2024.
- Pam Braun, Assessor, thanked the board for the approval of the new carpet for the Assessor's office.
- Angie Thompson, County Board office administrator, gave a reminder of the Flu Clinic on October 2, 2024 and a special Tax and Finance meeting on October 15, 2024 at 10:30 a.m.
