Chairman J. Douthit stated this agenda item needed formal action in order place the proposed FY25 budget for a 30 day layover. The proposed budget will be made available for public inspection. ### 6. APPROVE F&C CONCRETE AGREEMENT FOR HISTORIC COURTYARD AND GAZEBO PROJECT WITHOUT COMMITTEE RECOMMENDATION

Chairman J. Douthit stated he has met with the contractor and all funding has approved. Aaron Jones, States Attorney, stated a provision was added to the agreement to require lien waivers from subcontractors from the general contractor. Member T. Ellis made motion to approve the F & C Concrete agreement with the additional verbiage. Member D. McCain seconded. *Motion carried* on a roll call vote 8 ayes; 0 nays; 0 absent; 0 abstain.

### 7. ELECTION OFFICIALS REPORTS

- Michelle Kollmann, County, Clerk, stated the preparation for the November General Elections is moving along. As of today, they had over 2000 early voters, mailed out around 1650 ballots with a total of approx. 725 ballots having been returned back to the office. Last week the State Board of Election conducted an internal test of the DS200 tabulators and they found no issues. This Friday, October 25 at 9:00 a.m. our office will hold the public test and the public may attend.
- Deb Ruholl, Treasurer, informed the board the second installation of taxes were due on October 18 and over 63 million dollars in taxes have been collected. The second distribution of taxes will take place on November 18. Also, certified letters for unpaid taxes will be mailed on November 8.
- Angie Thompson, County Board office administrator, informed the department heads the budget for their office will be sent out for review.

### 8. COMMITTEE REPORTS

- Doug McCain noted CEFS is looking for some help.
- Tim Ellis thanked Sheriff Paul Kuhns on his hard work with the Opioid treatment plan. Also, a thank you to Chairman Josh Douthit for his efforts on the Courtyard and Gazebo project and partnering with the City of Effingham for additional funds.
- Josh Douthit also thanked the City of Effingham for the additional funds and the working relationship the County and City have.
- Josh Douthit noted Hope Trust will be on site at the County Building for open enrollment with county employees on October 22 from 8:00 a.m. to 9:30 a.m. He thanked the county board members for their support on the \$1,000.00 employee monthly stipend.
- Josh Douthit talked about the completed window replacement project with Superior Windows Co. He complimented Chad Walls on his assistance with the project.
