10. Next Scheduled Board of Health Meeting: Tuesday September 03, 2024.

We will likely try to have a Board of Health Building & Grounds Committee meeting in July to review options for the tree in front of the 901 West Virginia site, possibility of installing a culvert / removing some trees on the Arora lots on West Virginia, and the possibility of doing curb cuts and installing an exit at the south western end of the parking lot at East Blohm.

The September meeting is when we normally vote to recommend the ECHD's Proposed Budget to the County Board for approval.
