#### 3. New Business

- Proclamation Support Your Local Chamber of Commerce Day
   Member J. Douthit noted this is an annual proclamation to support your local Chamber of
   Commerce. Member J. Douthit made a motion to recommend to the full board to approve the
   proclamation to Support Your Local Chamber of Commerce Day. Member T. Ellis seconded.
   Unanimous. *Motion carried.*
- Resolution Advisory Referendum to Voters Regarding Federal Scholarship Tax Credit Member J. Douthit stated the board was approached by a lobbying entity to place this non-binding advisory referendum on the ballot for the General Primary Election which will take place on March 17, 2026. The referendum is in regards to a federal scholarship tax credit and will allow individuals to make donations to public or private schools for expenses. The state would need to opt into this federal program. It was noted Aaron Jones, States Attorney, has not reviewed the resolution. However, the resolution has standardized wording for all Illinois counties. The question on the ballot would read as "Should Illinois opt into a federal program that would provide Public K-12, private school, and homeschool students with privately

donated funds for academic needs, such as tutoring and test preparation, educational therapies for students with disabilities, tuition, books, exam fees or for other specified academic needs? Yes No". Member J. Douthit made a motion to recommend to the full board to approve the resolution for the Advisory Referendum to Voters Regarding Federal Scholarship Tax Credit pending legal approval from the States Attorney. Member N. Soltwedel seconded. Unanimous. *Motion carried*.

Resolution – State's Attorneys Appellate Prosecutor Aaron Jones, States Attorney, stated this annual resolution is required to be approved for the State's Attorneys Appellate Prosecutor. This is to provide services to the State's Attorney's office and the annual fee is \$18,000.00. It was noted the Appellate Prosecutor office handles all appeals, conflicts of interest, major case review and provides free educational seminars. Member S. Rich made a motion to recommend to the full board to approve the Resolution for the State's Attorneys Appellate Prosecutor. Member J. Deters seconded. Unanimous. *Motion* carried.

#### Human Resources Practices

Member J. Douthit informed the board the County doesn't have a human resources director. The board will be working with Bushue Human Resources to make sure departments are following the best practices and the correct processes to be more compliant. This is to help prevent any possible liability. In the next few months Josh will be working with each department to review best practices.

Member M. Buzzard informed the board of an inquiry with property taxes on timberland. There was additional discussion on forestry management program, the assessed value, class codes on the property and statutory changes on assessments. However, it was noted the landowner should contact the Assessor's office.
