Dispatch Report/Mutual Aid Report

- RuralMed shared reporting for months of June and July.
 - August report of 515 total requests for ambulance; 371 911 requests; 33 private line requests; 115 refusals; 111 other calls; 14 mutual aids given; 8 mutual aids received; 0 standbys.
 - September report of 573 total requests for ambulance; 392 911-requests; 49 private line requests; 97 refusals; 132 other calls; 8 mutual aids given; 3 mutual aids received; 0 standbys.

Recruitment (training, certifications)

• RuralMed reported one new hire for August/September.

Quality Compliance

- RuralMed report showed August chute time average 1 minute 17 seconds; response time average 8 minutes 52 seconds; scene time average 16 minutes 12 seconds.
- RuralMed report showed September chute time average 1 minute 13 seconds; response time average 7 minutes 40 seconds; scene time average 15 minutes 45 seconds.

Daniels shared report of status-0 calls since August and found 44 started; Of the 44, she reporting finding four she felt were concerning in terms of how many rigs were available for Effingham County at the recorded times.
