Dispatch Report/Mutual Aid Report

- RuralMed shared reporting for months of December and January.
 - December report of 378 total requests for ambulance; 301 911 requests; 77 private line requests; 95 refusals; 14 cancelled in route; 8 mutual aids given; 0 mutual aids received; 1 standby.
 - January report of 421 total requests for ambulance; 352 911-requests; 69 private line requests; 93 refusals; 14 cancelled in route; 0 mutual aids given; 0 mutual aid received; 0 standbys.

Quality Compliance

- RuralMed report showed December chute time average 1 minute 33 seconds; response time average 7 minutes 39 seconds; scene time average 18 minutes 32 seconds
- RuralMed report showed January chute time average 1 minute 10 seconds; response time average 8 minutes 5 seconds; scene time average 14 minutes 45 seconds.

Commendations/Complaints

• RuralMed reported one documented concern from 911 dispatch in December involving extended chute time and ETA to scene. RuralMed reported resolution implemented.
