Dispatch Report/Mutual Aid Report

- RuralMed shared reporting for months of June and July.
 - June report of 488 total requests for ambulance; 338 911 requests; 57 private line requests; 120 refusals; 93 other calls; unreported mutual aids given; 23 mutual aids received; unreported standbys.
 - July report of 492 total requests for ambulance; 320 911-requests; 55 private line requests; 99 refusals; 96 other calls; 7 mutual aids given; 17 mutual aids received; 1 standby.

Recruitment (training, certifications)

• RuralMed reported two new hires for June/July.

Quality Compliance

- RuralMed report showed June chute time average 1 minute 21 seconds; response time average 7 minutes 14 seconds; scene time average 16 minutes 58 seconds.
- RuralMed report showed July chute time average 1 minute 19 seconds; response time average 7 minutes 46 seconds; scene time average 15 minutes 48 seconds.

Commendations/Complaints

- RuralMed reported one (1) complaint in the month of June. RuralMed reported investigating complaint and resolution has not been completed at this time.
- RuralMed reported no (0) complaints in the month of July.
- J. Deters provided commendation in which RuralMed crew went above and beyond in taking the initiative to contact Cumberland County to request assistance with mutual aid during a recent large stream of accidents on I-70.
- B. Yochum provided commendation for RuralMed at barn fire in which RuralMed crew actively assisted fire crews wherever needed.
