- Effingham County Public Transportation (ECPT)
 - o May Service Report provided by J. Althoff
 - B. Beck-Marts' report showed May service report of 2,570 total passenger trips, 12 new riders, 40 unmet rides, and 380 non-ambulatory rides.
 - B. Beck-Marts' report showed May demand response trip purpose report of 401 medical, 1,720 employment, 49 nutrition, 43 business, 55 shopping, 74 social/recreational, 17 other, and 0 educational purposes.
 - B. Beck-Marts' report showed reduced fair report of 342 seniors, 301 disabled residents, 42 veterans for demand response.
 - o E-Trax Update
 - B. Beck-Marts reported 211 total units with 9.6 as the average per day and 1.2 as the average rides per hour.
 - B. Beck-Marts reported reduced fair for E-Trax of 66 seniors, 48 disabled residents, and 12 veterans with \$0.00 donations received.
 - N. Soltwedel inquired on any interest in new stops. J. Althoff responded at point of reevaluation and may possibly eliminate one of TA Truck Stop stops and add others.
 - o Rebuild Round 3 Grant (Maintenance Facility) K. Lockhart stated bid out architectural and engineering. Received 7 responses. Scored Farnsworth Group the highest. In next 30 days will work with Farnsworth to get a contract and get approval from IDOT. Will then bring back to the board for approval.
