Detailed Inspection Report

Property: Museum, 100 East Jefferson Avenue, Effingham, IL 62401

Inspection Date: Wednesday, December 4th, 2024, 10:30 AM

Inspected Areas: Roof, Clock Tower Cedar Siding, Mansard Roof Cedar Siding

Findings:

Roof:

- A core test was conducted to assess the insulation thickness.
- The EPDM (Ethylene Propylene Diene Monomer) roofing material is in fair condition.
- Maintenance or an EPDM overlay is recommended.
- The existing roof has only one layer. A complete removal may be unnecessary. According to Illinois building codes you are permitted up to two layers of roofing products.

Clock Tower:

- The existing cedar shake siding on the clock tower is generally in fair condition.
- Approximately 500 square feet of cedar shake siding needs replacement due to rot and significant cracking.

Mansard Roof:

- The cedar shake siding on the mansard roof is in poor condition and requires removal and replacement.
- Significant warping, cracking, and aging are evident.

Recommendations:

- **Roof:** Conduct regular maintenance on the EPDM roof and consider an EPDM overlay when necessary.
- **Clock Tower:** Replace the damaged cedar shake siding (approximately 500 square feet) to prevent further deterioration and water intrusion.
- **Mansard Roof:** Remove and replace the existing cedar shake siding with a new material to ensure proper weather protection and improve the overall appearance of the building.

Mansard Cedar Shake Roof Replacement

Scope of Work

1. **Safety First:** We will strictly adhere to all OSHA safety standards to ensure the well-being of everyone involved and those in the vicinity of the work area.
2. **Access:** We will provide all necessary lifts to reach the work areas.
3. **Removal:** We will remove all existing cedar shake.
4. **Inspection and Repair:** We will inspect all wall sheathing and replace any rotted wood at a cost of \$3.50 per square foot.
5. **Weatherproofing:** We will install house wrap on all sheathing walls to reduce wind infiltration.
6. **Sealing:** We will apply self-adhesive flashing tape to all windows, inside and outside corners, to prevent leaks and create an air barrier.
7. **Starter Course:** We will install a starter course on the bottom row.
8. **New Cedar Siding:** We will install new rounded cedar siding to match the existing siding with a 7.5-inch reveal.
9. **Caulking:** We will caulk all windows, trim, and ledges as needed.
10. **Waste Removal:** We will provide all necessary dumpsters.

Warranty:

- All labor is covered by a 7-year warranty.
- Material warranties are detailed in the attached document.

Total Cost: \$154,995

Scope of Work:

- Removal and replacement of up to 500 square feet of cedar shake.

Cost: \$16,500

Enhanced Scope of Work for 60 Mil White TPO Overlay Installation

Project Overview:

This project outlines the installation of a 60 mil white TPO (Thermoplastic Polyolefin) roofing membrane over the existing roof using a mechanically fastened system. The project includes the necessary steps for surface preparation, membrane installation, flashing integration, and project completion.

Detailed Scope of Work:

1. Surface Preparation:

- Thoroughly inspect the existing roof surface to ensure it is clean, dry, and free of debris, loose materials, or any protrusions that may damage the new membrane.
- Address any necessary repairs or modifications to the existing roof surface to ensure a smooth and even substrate for the TPO installation.
- Install a $\frac{1}{2}$ " fan fold insulation layer over the entire existing upper roof surface to enhance thermal performance and energy efficiency.

2. TPO Membrane Installation:

- Mechanically fasten the 60 mil white TPO membrane to the roof deck using fasteners and plates at a rate of 8 fasteners and plates per 100 square feet.
- Ensure proper overlap and seam welding of the TPO membrane sheets to create a watertight seal.
- Adhere to the manufacturer's recommended seam welding techniques and quality control procedures.
- Secure the TPO membrane at all seams with additional fasteners and plates every 12 inches for enhanced wind resistance and durability.

3. Flashing and Pipe Boot Installation:

- Install all new flashings, pipe boots, and counterflashings at roof penetrations, transitions, and terminations to prevent water infiltration.
- Ensure proper sealing and integration of all flashings with the TPO membrane and adjacent roofing components.
- Utilize appropriate sealants and adhesives compatible with the TPO membrane and flashing materials.

4. Clock Tower Termination:

- Install termination bars at the end of the TPO membrane on the clock tower to secure the membrane and provide a clean, finished edge.
- Apply a high-quality, weather-resistant caulk as needed to seal the termination bar and prevent water intrusion.

5. Project Completion:

- Conduct a comprehensive final inspection of the entire roof system to ensure all components are installed correctly and the roof is watertight.
- Address any identified deficiencies or areas requiring additional attention.
- Provide the owner with a detailed project completion report and any necessary maintenance instructions for the TPO roof system.

Cost Estimate:

The total estimated cost for this project is \$73,995. This includes all materials, labor, equipment, and necessary permits.

20 year warranty for roof

- **Safety:** All work will be performed in accordance with OSHA safety regulations and best practices.
- **Permits:** All necessary permits and approvals will be obtained before the start of the project.
