JOB DESCRIPTION- Remove and replace shake shingle mansard roof. Coat existing Rubber Membrane roof.

DESCRIPTION OF WORK:

Rubber Roofing (Main Section)

- Apply Elastomeric coating system to Rubber roof. (White, 2-Coat System)
- Repair any patches, corners, and/or protrusions as necessary. \$63,970.00

Mansard Wood Shake Roofing (Lower Section Only)

- Remove existing wood shake Mansard roofing lower level only
- Repair and replace any structural woodwork if needed, extra cost of material plus labor.
- Install new aluminum flashing around dormers, valleys, and hips as needed for watertight roof.
- Includes Install new synthetic base and/or ice and water barrier shield.
- Clean up of all debris Daily
- Option 1: Install New Brava Synthetic shake/slate Roofing System. -- \$169,000.00
- Option 2: Install New Wood Cedar shakes. \$196,000.00

Rubber inlaid transition/overhang

- Remove and Replace Rubber inlaid transition/overhang in order to complete work of **Mansard wood shake roofing.**
- Includes lean up of all debris Daily \$67,000.00

Clock Tower

- Remove existing wood shakes on sides and top of clock tower.
- Repair and replace any structural woodwork if needed, extra cost of material plus labor.
- Install new aluminum drip edge, flashing as needed.
- Install new synthetic base and/or ice and water barrier shield
- Clean up of all debris Daily.
- Option 1: Install New Brava Synthetic shake/slate Roofing system. \$122,055.55
- Option 2: Install New Wood Cedar Shakes. \$136,111.11

Remove and Replace existing gutter with 6' seamless gutters: \$20,800.00
Lift Rental cost: \$6,000.00
